Regular Meeting

The Deuel County Commissioners met in regular session on Tuesday, October 6<sup>th</sup> at 9:00 a.m. in the Commission Room of the Courthouse with Vice Chairman Rhody presiding as acting Chair in the absence of Gary Jaeger. Those present were Commissioners Kreutner, Homan and Rhody. Absent was Gary Jaeger. Commissioner DeJong was present by Zoom platform and by phone. Because of the Zoom platform, Vice Chairman Rhody requested all motions be made on roll call vote. Also present was Auditor Mary Korth, State's Attorney John Knight, Zoning Officer Jodi Theisen and several members of the public. The meeting began with prayer and the Pledge of Allegiance.

**Approval of Agenda**

1) Homan moved, seconded by Kreutner to approve the agenda as presented. Roll call vote, all yes and the motion carried.

**Approval of Minutes:**

2) DeJong moved, seconded by Kreutner to approve the minutes of the regular meetings of September 1<sup>st</sup> and 17<sup>th</sup>, 2020. Roll call vote, all yes and motion carried.

**APPOINTMENTS**

**9:00 Highway Superintendent Jamie Hintz and Foreman Jamie Broksieck**

Hintz and Broksieck met with the Commissioners to discuss several highway related issues. Discussion was held on the Five Year Highway Bridge Improvement Plan. The plan is in place as what is required.

3) Homan moved, seconded by Kreutner to approve Resolution #20-31 A Resolution Adopting the Deuel County Five-Year Highway and Bridge Improvement Plan. Roll call vote, all yes and motion carried.

**A RESOLUTION ADOPTING THE DEUEL COUNTY FIVE-YEAR HIGHWAY AND BRIDGE IMPROVEMENT PLAN**

WHEREAS, the South Dakota Department of Transportation Local Bridge and Improvement Grant Fund requires that in order to be eligible to apply for Bridge Improvement Grant funds, Counties are required to develop a five-year Highway and Bridge Improvement Plan, hereinafter referred to as Plan; and

WHEREAS, Deuel County has utilized the South Dakota Department of Transportation, County Staff, the First District Association of Local Governments, Townships, and the general public in developing the various components of the Plan; and

WHEREAS, the Plan includes maps and lists identifying an inventory of highways and bridges, project needs, and revenue sources; and

WHEREAS, Deuel County held a public meeting on September 17, 2020 to solicit input into the Plan, and the citizens who attended expressed an interest in the Plan; and  
WHEREAS, the County will be able to use the Plan as a tool to budget for transportation enhancements and better coordinate transportation issues with other entities;  
NOW, THEREFORE, BE IT RESOLVED BY THE DEUEL COUNTY BOARD OF COUNTY COMMISSIONERS THAT THE DEUEL COUNTY FIVE-YEAR HIGHWAY AND BRIDGE IMPROVEMENT PLAN IS HEREBY ADOPTED AND IS RECOGNIZED AS THE HIGHWAY AND BRIDGE IMPROVEMENT PLAN FOR DEUEL COUNTY.

Discussion was held on the open position for truck driver which is now closed and interviews completed. There is an applicant who lives outside the county and Hintz felt he is a good applicant and would encourage him to move to Deuel County. State's Attorney John Knight was present and stated that it is not a current requirement in Deuel County's policy to hire within county lines for the Highway Department. Rather the job description is tied to whether they can perform their duties related to the job and be punctual by living outside county lines. 4) DeJong moved, seconded by Kreutner to hire Matt Fieber as position of truck driver at starting pay of \$17.00 per hour. He will begin pending his other employment. Roll call vote, all yes and motion carried.

Discussion was held on the rate of pay going forward after Foreman Broksieck assumes the Superintendent position Nov. 1<sup>st</sup> as well as Marty Brown assuming the position of Foreman. Recommendations were made after reviewing current salaries. 5) Homan moved, seconded by Rhody to increase the rate of pay for Jamie Broksieck to \$4225.87 monthly salary for November and December 2020. Also, to include the increase for Marty Brown to \$22.71 per hour for November and December 2020. Both increases begin Nov. 1, 2020. Roll call vote, all yes and motion carried.

Discussion was held on current Superintendent Hintz's vacation hours that have accrued and what should be allowed for payout upon retirement. Payout of Hintz's vacation will affect the Highway salary budget and it will have to be supplemented slightly. 6) Homan moved, seconded by Rhody to pay out all accrued vacation hours at the rates earned each prior year they were accruing. This will be paid on his final paycheck as Highway Superintendent. Roll call vote, all yes and motion carried.

Discussion was held to consider the adoption of the following departmental budget supplement to the 2020 Deuel County budget, in order to carry on the indispensable functions of Deuel County. 7) Kreutner moved, seconded by DeJong to advertise and hold a supplemental budget hearing November 17. Roll call vote, all yes and the motion carried.

**9:30 Emergency Manager Sheila Monnier – Appointment Postponed to After Public Hearing**

Monnier met with the commissioners and gave updates. She obtained certification as an Emergency Manager and updated the Board on her classes and trainings related to certification.

Discussion was held on the increase of positive numbers concerning Covid-19 in the county and surrounding areas. Monnier presented a new proposal for the quarantine policy for county employees as it is a hardship to the offices to be absent for a 14 day quarantine. Auditor Korth also presented information on what is considered essential employees and critical infrastructure for the county. She

feels with the election fast approaching, it is necessary for her office to work as much as possible. She also stated several other offices could become too short staffed if the policy remains as is. 8) Homan moved, seconded by DeJong to make an emergency amendment to determine essential workers and modify the policy for those employees, determine what is now considered "close contact" and allow employees to come to work in certain circumstances as long as they social distance, wear masks at work at all times for 14 days and monitor symptoms. If there are any symptoms of Covid-19 they would have to go home and isolate. Roll call vote, all yes and motion carried. Knight will draw up the amended resolution but this is motion is in effect immediately.

Monnier had a change in vendor for the radios that were ordered and approved at a prior meeting. Because of the vendor change, the grants that are offered are for two different grant years. 9) DeJong moved, seconded by Rhody to approve the purchase of the radios for the fire departments from Motorola Solutions Inc. in the amount of \$27,334.04 using Homeland Security Grants from 2019 already allocated for 2020 and a purchase of radios for the EOC from same vendor at \$13,523.65 using Homeland Security Grants 2020 for 2021. HSG will be reimbursing in the year 2020 and these radios will be paid upon receiving them. Roll call vote, all yes and motion carried.

Monnier presented two different projects for grants she had been working with First District Development that would be of no cost to the county. The State reimburses 80% of funding and First District will apply the remainder to the 2021 Annual dues for Deuel County as local match.

The first project discussed was the PDM (Pre-Disaster Mitigation) plan. These are FEMA grant funds developed by First District who needs the plan approved and signed by the Board of Commissioners. 10) Homan moved, seconded by Kreutner to approve and sign the PDM agreement with First District at a contract cost of \$15,980.00. Grant funds will reimburse \$10,985.00 and the remainder will be applied to Deuel County's 2021 annual dues towards the project. Roll call vote, all yes and motion carried. Monnier presented the second contract with First District and the County for the development of CFS (Commodity Flow Study, which has to do with the flow of trucks through the county on the highways) for another grant award. 11) DeJong moved, seconded by Kreutner to approve and sign the agreement with First District at a contract cost of \$8000.00. Grant funds will reimburse \$6400.00 and the remainder will be applied to Deuel County's 2021 annual dues towards to the project. Roll call vote, all yes and motion carried.

#### **9:45 Sheriff Cory Borg – Appointment Postponed to After Public Hearing**

Borg was unable to meet with the commissioners. Auditor Korth presented Law Enforcement Contracts on his behalf. The new 2021 Police Contracts between the cities of Brandt, Gary and Astoria were available and presented. The hourly rate was increased due to CPI from \$35.00 to \$35.50 per contract hour. The annual rate for the City of Gary for 2021 will be \$6083.28 or \$506.94 monthly. The annual rate for the City of Brandt for 2021 will be \$1810.44 or \$150.87 monthly. And the annual rate for the City of Astoria for 2021 will be \$3254.64 or \$271.22 monthly 12) Kreutner moved, seconded by Homan to approve and sign the 2021 police contracts with the Cities of Brandt, Gary and Astoria as described above. Roll call vote, all yes and motion carried.

#### **10:00 Notice Of Public Hearing Of The Deuel County Board Of County Commissioners On Proposed Repeal Of Ordinance Number 89-2, The Ordinance Regulating The Drainage Of Ponds, Sloughs And Lakes Or Any Series Thereof In Deuel County , South Dakota**

The first reading was held in the Deuel County Commission Room, second floor of the Deuel County Courthouse of the consideration for repeal of Ordinance Number 89-2, The Ordinance Regulating The Drainage Of Ponds, Sloughs And Lakes Or Any Series Thereof In Deuel County , South Dakota. Present for the hearing was State's Attorney John Knight, Drainage Officer Jodi Theisen, Auditor Mary Korth, Commissioners Steven Rhody, Judith Homan and Roger Kreutner. Present by Zoom platform was Commissioner Gary DeJong. Also present Jay Gilbertson of East Dakota Water Development District and several members of the public. Written testimony was received in the Auditor's office prior to the meeting and was read by Auditor Mary Korth. Greg and Joan Gibson of Goodwin, SD wrote "We would like to state we want the Drainage Board and permitting process to continue in Deuel County, so land owners are protected, and have legal rights in keeping the value of their land intact."

Gary Magedanz asked how the current drainage ordinance reads. States Attorney John Knight was present and stated the current ordinance says that drainage in excess of 20 acres requires a permit from the drainage board to inform downstream landowners. It was intended to help disputes between neighbors. Deuel County required downstream landowners to give permission, but this is outside the ordinance and the Drainage Board is responsible for determining which landowners would be affected. Most counties that repealed the drainage ordinance was because it isn't the county's decision to mediate between landowners.

A sign-in sheet was provided for guests and concerned citizens. Landowners present: LeAnn Swenson, Greg Gibson, Joan Gibson, Jerry Zubke, Kelly Sieh, Paul Eastman, Gary Magedanz, Larry Goodroad, Randy Kruse, and Roy Megard. Landowners present by Zoom or phone: Ross Vanderbush, Gloria Knutson, and Todd Hanten.

**Public Comments:**

Larry Goodroad stated that he feels the drainage board is a good thing and is in favor of keeping the ordinance.

Kelly Sieh is in favor of the Board and regulation on what people are doing and actually going through the process. But he does see that there are disputes and red tape to get permission. He wishes it would be more enforced.

Commissioner Rhody stated that it could be enforced with injunction but Knight feels the county will be in court a good amount of time while having an ordinance.

Jerry Zubke from Grant County was not in favor of having to get downstream landowners' permission. He also stated Grant County is considering repealing their ordinance as well.

Gibson is in favor of board. He states the court costs would be a hardship to young farmers whose land would be affected and can't fight it on their own.

Swenson stated that it is a hardship and without County control, they wouldn't know time frame of when the drainage would be completed and not wait for the courts.

Todd Hanten stated in the 1980s tiling was a good idea but he wasn't able to start the process until the 1990s. Early 2000s there was a lot of tiling going on. They received permission. Codington County was an easier process. In Deuel County the tile couldn't be repaired because they didn't get downstream landowners permission and could not proceed. Vice Chair Rhody cautioned he wanted general opinions and not a specific case. Hanten's concern was that downstream landowners have

control above state law. He feels the majority of counties have repealed drainage because of this. He is concerned about his current permit.

Eastman stated his case and is in favor of a board policing the case. He feels some are doing drainage without permission currently.

Sieh stated downstream landowners only apply when the Board wants it to. How far will downstream landowners go? Knight stated it is a uniform policy the Board has tried to implement, though some have gotten missed but not intentionally ignored. Hanten said it is a flawed system.

Randy Thompson called previously and Knight relayed Thompson was in favor of keeping the ordinance as well.

Megard wanted to know why it would be a good idea to be discontinued.

Gilbertson has encouraged Deuel County to get out of drainage. Under current law it states the county has determined what is true by allowing a permit and no downstream owner is adversely affected. The permitting system is flawed. The law is concerned with downstream impact but the determination would have to be correct. Processes are not followed. He feels the effort was well intended but it leaves many problems current day. He cited court cases in which the processes are not being closely followed and the counties are at fault with a flawed permitting system. Permits do not offer a level of protection that follow the law.

Gloria Knutson is in favor of the drainage process and board because of the costs of other landowners against those who can afford it.

Vice Chair Rhody concluded the meeting by thanking everyone who came and gave their comments. A second reading will be held Oct. 20, 2020 at the Deuel County Commission meeting. Time TBD.

#### **10:45 Second Reading Ordinance B2004-01-29A**

The second reading of Ordinance B2004-01-29A was held. The Ordinance Amendment would be amended to adopt the changes to Article XI Section 1101.03 Special Exceptions to include breweries and distilleries. No further testimony given. 13) Homan moved, seconded by DeJong to approve, adopt and publish notice of adoption of Ordinance B2004-01-29A, An Ordinance Entitled, An Ordinance to Amend Article XI Section 1101.03 Special Exceptions Adopted by Ordinance B2004-01, July 6<sup>th</sup>, 2004, as amended, of the Zoning Ordinance of Deuel County. A roll call vote was held. Kreutner aye, Homan aye, DeJong aye, Rhody aye. Unanimous vote. Motion carried.

#### **11:00 Supplemental Budget Hearing**

The scheduled supplemental budget hearing was held with no one attending the hearing. 14) DeJong moved, seconded by Rhody to approve Resolution #20-32 A Resolution Supplementing Appropriations for Deuel County, South Dakota for the Year 2020. Roll call vote, all yes and motion carried.

**11:15 Jerome DeBoer**

DeBoer met with the commissioners to discuss a road approach on West Hwy. 22 for DeBoer Construction which may conflict with the County property (Extension building) located there. There is a shared approach between the County and DeBoer Construction as the State does not allow for three approaches to those businesses. DeBoer has offered to take out the County shared approach and grant the County an easement to use DeBoer's approach to enter the property for Extension. State's Attorney Knight will prepare an easement if it is agreed to by all parties. 15) Homan moved, seconded by Kreutner to allow DeBoer Construction to remove the County shared approach at no cost to the County upon the condition DeBoer Construction signs an easement and has it recorded at the Register of Deeds Office so that the County has access to DeBoer's approach for entrance to the County West Building. This would include signing the application for Highway Access Permit from the State of SD. Roll Call vote, all yes and motion carried.

Discussion was held on the benefits of contracting a Human Resources manager part time. Natalie Remond of Multi-Business Solutions met with the Board last meeting for an overview of what she can offer to the county. She could not give a formal quote until the Board presents what specifically is needed from her. Auditor Korth and the Commissioners discussed different areas needing HR attention. Auditor Korth will develop a formal proposal and send to Natalie Remond for her review and await a quote for services. This will be compared to other quotes the Board is looking at in the future.

**Surplus Items; Meeting Date Change; Payroll Tax Deferment; Clerk of Courts Bullet Proof Glass**

18) Kreutner moved, seconded by Rhody to surplus the following items for Director of Equalization for scrap as items deemed no value: Onyx Fabric Office Chair, HP6812 Printer S#TH65J810PN, and a Power Backup. Also surplus scrap iron for the Highway Department for recycle. Roll call vote, all voted yes and motion carried. Further discussion was held on the installation of the new courthouse windows currently being done on all floors. Some offices declined to keep the vertical blinds to be put back on the windows. The blinds are old and crack easily. Discussion was held on looking into new window treatments and getting a quote for the courthouse so all offices can be uniform. The blinds that are unused will be kept in storage until new treatments are decided.

19) DeJong moved, seconded by Rhody to change the first meeting in November to Thursday, November 5<sup>th</sup>, 2020 due to Election Day being Nov. 3<sup>rd</sup>. Roll call vote, all yes and motion carried.

Discussion was held on the Presidential memorandum instructing the Department of Treasury to defer the collection of the 6.2% payroll tax contribution (paid by employees) which partially funds Social Security. This order impacts employees making less than \$4000 every two weeks and only is allowed from Sept. 1, 2020 to Dec. 31, 2020. This does not eliminate the taxes, only a deferment which is due upon a date determined by the Federal Government. 20) Homan moved, seconded by Rhody to NOT defer payroll taxes for Deuel County and not participate in the Presidential memorandum to the Department of Treasury. Deuel County will continue to monitor this development and will update employees if and when additional guidance is released that necessitates action. Roll call vote, all yes and motion carried.

Discussion was held on a quote received from Midwest Glass in Brookings for ballistic glass to be installed in the Clerk of Courts Office. This comes as a recommendation from The Third Circuit Court

Administrator. Auditor Korth presented the quote and informed the Commissioners she spoke with Clerk of Court Sandy Reichling. Korth and Reichling understand that larger counties may feel the need to install protective glass, but feel it might not be necessary for smaller counties. State's Attorney John Knight also felt it was an unnecessary measure for our smaller county. Other smaller counties in this jurisdiction are not installing the glass. It would be costly for the county even with the State paying for part of the costs. Furthermore it would be the only office which such protection. It was decided to decline the quote and not have the ballistic glass installed in the Deuel County Clerk of Courts Office.
