The Deuel County Commissioners met in regular session on December 3, 2024 at 9:00 AM in the Commission Room of the Courthouse with Chairman Jay Grabow presiding. Those present were Commissioners Jay Grabow, Steve Rhody, Scott Fieber, Harry Mewherter and Judith Homan. Also present was Auditor Courtney Parker. The meeting began with prayer and the Pledge of Allegiance. 1) Homan moved, seconded by Fieber to approve the agenda with additions of Weed Supervisor Keith Goens and Sheriff Cory Borg. All voted yes and the motion carried. 2) Mewherter moved, seconded by Rhody to approve the minutes from November 7th and 19th with corrections on November 7th meeting: 1) motion was seconded by Grabow and to take out names on the tax deed process. All voted yes and the motion carried.

Appointments

9:00 AM – Highway Foreman Marty Brown

Brown gave some rates for doing township work from snow removal and road blading. He stated Broksieck wanted the commission to look at the rates and decide if they would like to raise them for the contracts with townships starting April of 2025.

Brown stated legal counsel Jack Heib wants to draft a letter explaining Duininck is still under contract on county road 6 and 513. If they don't fix the roads, Deuel County can then go to the bonding agency for the warranty work.

Brown updated the commission on the conversation with SDTAT about the RAIF program to see if there's a timeline approved projects need to be done by. SDTAT suggested the county making a resolution to encourage getting the projects done in a timely manner. There will be more discussion on this topic in coming meetings.

9:25 AM – Weed Superintendent Keith Goens

Goens asked for permission to go to state convention. Goens stated the county receives roughly a \$5600-\$6000 grant if you go to state convention. There must be two people that go to the state convention on your county's behalf. 3) Rhody moved, seconded by Mewherter to approve Goens and one other to go to the state convention in February. All voted yes and the motion carried.

Discussion was had on spraying township and county roads. Homan stated she was asked by a member of the community if the township roads are getting the attention they should. Goens replied that they are. Goens explained that in most counties the townships and/or land owner is in charge of having their land sprayed. He stated the townships were all sprayed once, with some sprayed twice. Grabow stated mowing the ditches may be a task that needs to be completed between the highway department and the weed department if there are days when the weed department can't spray. Grabow stated it is a lot easier to blade roads when the weeds and grass is cut back.

9:40 AM - Sheriff Cory Borg

Borg called in via telephone conference. He explained to the commission that the 2021 Chevy pickup is in the shop at Fritz Chevrolet. He believes it needs a new transmission. Since the transmission will be over \$1,000.00 Borg wanted the commission to approve it but does not know the quote yet. The pickup has roughly 130,000 miles on it. 4) Fieber moved, seconded by Homan to approve a new transmission for the 2021 Chevy pickup. All voted yes and the motion carried.
