### 9:00 AM – Highway Superintendent Jamie Broksieck

Broksieck gave updates to what has been going on in the highway department. He stated there is eight townships that have turned in 5-year road and bridge plans. Applications for the RAIF projects are due on October 31. Broksieck stated they put 48 stop signs on the 12 miles of road on 478<sup>th</sup> Ave. for the safety of the public driving that road due to the closure of Hwy 15. He also stated they are blading the road twice a week. Striping will start this week on all the chip sealed roads. In addition, they are putting more shoulder on the Stranburg road.

Jim Daily expressed his concerns due to the blading and weeds on some township roads. He said they have been a problem for nearly 10 years. Daily stated they don't cut the road wide enough and they deliver too much gravel leaving a very tall gravel windrow, so tall they are unable to mow the shoulder of the ditch. Grabow discussed we need to mow more often or spray the entire ditch. The board decided they would invite township officials to the next meeting so they can figure out a plan of attack. 2) Mewherter moved, seconded by Homan to invite township officials to the next meeting on September 16, 2024 at 11:30 AM to talk about mowing ditches. All voted yes and the motion carried.

Grabow asked how the new hires were coming on their CDL's. McCracken passed her CDL and Lovre has one more written test. Then they both will get more driving time before they take the driving test.

Broksieck stated the horse arena tractor is going to need to be replaced sometime in the near future.

the general fund. Causing the budget to look expense heavy in the highway fund. The commissioners discussed the budget in its entirety. 5) Fieber moved, seconded by Mewherter to move Parker from step three to step five. All voted yes and the motion carried.
