Beutler stated the parcel of land his home is on is 18.8 air miles from his parcel of land he farms; therefore, he believes it should qualify. This topic is tabled until next meeting May 7<sup>th</sup>, 2024 at 9:30 AM to hear from the Director of Equalization.

#### 10:15 AM – CLAD Executive Director Sarah Salzer

Salzer gave her quarterly report about things happening within the CLAD organization. Salzer stated CLAD sold one industrial and one residential lot. Salzer is going to call 1<sup>st</sup> District to get some loans and/or grants to work on building a road out by the purchased lots. Salzer stated they are working with Banner on this project. Salzer spoke at the annual weed meeting talking to the townships and how she is available to help them with anything they need. The Commissioners thanked her for all she does for the townships. CLAD received the first portion of the childcare grant however did not receive the second portion. They will be looking into an after-school program and other possibilities with the funds they received. Salzer took a grant writing course that was eight weeks long. CLAD is involved in the Healthy Hometowns committee which helped create a sled library and another water bottle filling station out by Deuel County Sports Complex. They received a grant and working on another to help fund the project. Deuel School will maintain once it is up and functioning. 5) Rhody moved, seconded by Fieber to approve the water filling station. All voted yes and the motion. Grabow suggested Salzer reach out to Angel with Gate City Development for help with grants and funding of projects. CLAD provided resources to Astoria & Goodwin Fire Department for grant opportunities for their buildings. Salzer brought up building a dog park. The board explained to her that they think that's more of a city project versus a county wide

project. 6) Fieber moved, seconded by Homan to approve the quarterly funds of \$4,500.00 for CLAD. All voted yes and the motion carried.

#### 10:25 AM – County Health Nurse Tammy Baer

Baer presented her quarterly report to the Board. WIC caseloads have been going up, ASQs (Ages and Stages Development/Social Emotional Screenings) 5, immunizations at 79 for first quarter. Baer completed WIC trainings, Civil Rights, Blood Borne Pathogen, Partners for a Healthy Baby Curriculum, Late Preterm Infant Webinar and Teletask Training. WIC program compliance Review conducted on biannual basis to local site and it went very well.

Baer also explained that she is active in Healthy Hometown Committee and they are collaborating with CLAD to seek grant opportunities for a water bottle filling station to be located at the Deuel County Sports Complex. Healthy Hometown committee is also planning a celebration for Earth Day on April 22<sup>nd</sup> at which time a "Move More Challenge" will be kicking off. Interested community members can log their miles for six weeks to win a three-month gift certificate to the Wellness Center in Clear Lake. The board told Baer she only needs to come bi-annually to report to the Board of Commission. The Deuel County Commissioners thanked her for all she does for the people of Deuel County.
